Comprehensive Plan Update:

Review Environmental Assessment Form: The Board reviewed the EAF, Part 1, including consulting via cellphone with Jenny Loewenstein, Sustainability Program Manager for the Genesee/Finger Lakes Regional Planning Council. She advises the Village and the Comprehensive Plan Update Committee and confirmed that she had completed the EAF for the Village as much as needed to be done for this type of project. Trustee Yacuzzo mentioned he felt the Planning Board should be completing these types of assessments.

WHEREAS, the Village of LeRoy has proposed undertaking an update to their Comprehensive Plan to align the vision of the future with the goals and needs of the community; and

WHEREAS, the Village of LeRoy has reviewed the project and has concluded that the projects are subject to requirements of 6 NYCRR, Part 617;

NOW THEREFORE BE IT RESOLVED, that the Village of LeRoy hereby concludes that the Project is a Type I Action subject to the review requirements specified in 6 NYCRR, Part 617; and

BE IT FURTHER RESOLVED, that the Village of LeRoy hereby notifies all involved agencies of its intent to be designated Lead Agency for the purposes of conducting a coordinated review of the Project in accordance with 6 NYCRR, Part 617; and

BE IT FURTHER RESOLVED, that Greg Rogers shall serve as the responsible officer of the Village of LeRoy in the review of the Project; and

BE IT FURTHER RESOLVED, that the Mayor is hereby authorized and empowered to complete and sign the EAF for the proposed Action in accordance with the intent of this Resolution.

WHEREAS, upon review of the information recorded on the EAF and in consideration of the criteria for determining significance as set forth in NYCRR 617.7(c), the Village of LeRoy has reasonably determined that the proposed project will not result in a significant adverse environmental impact.

NOW, THEREFORE, BE IT RESOLVED by the Village of LeRoy that a SEQR Negative Declaration shall be filed in accordance with the requirements of the New York State Environmental Quality Review Act.
