Mayor Rogers called the meeting to order at 7:00 pm, followed by the Pledge to the Flag.

APPROVAL OF MINUTES: Trustee Bonacquisti made a **Motion to Approve the Minutes of the Board of Trustees Regular Meeting on 9/17/2025**. It was seconded by Trustee Kettle and passed unanimously.

DEPARTMENT CONSIDERATIONS:

LPD:

- Continued high-visibility patrols at school campuses (officer at each campus plus roving officer).
- In-service firearms training was completed; all officers passed.
- School/church safety: Coordinated with regional agencies and local churches; randomized walk-throughs and Sunday engagement well received; discussed on local radio.

STP:

- Capital Project: Nearing the end of the project. Initial startup failed due to faulty parts; awaiting replacements; restoration to follow successful startup and close-out.
- 2016–17 equipment maintenance: Long-lead parts being re-machined where feasible
- UV disinfection: One bank at ~12,000 hours (rated life). No efficiency drop observed, continue to monitor and order new bulbs in the spring.
- Pump stations (budgetary concept only): Proposed scope—new pumps (rag-handling), rails, radar level controls (non-contact), controls/electrical, and contingency for unknown plumbing after dewatering. No action taken; keep for budget talks. Note: capitalizing with state/federal funds would trigger 10-State Standards (e.g., generators) and materially increase costs.

STP & DPW:

- Pump stations (budgetary concept only): Proposed scope—new pumps, rag-handling, rails, radar level controls (non-contact), controls/electrical, and contingency for unknown plumbing after dewatering.
- This project is not on any capital project schedule. It could wait until next year but system originally put in approx. 1991.
- No action taken; keep for budget talks.

DPW:

- Leaf season starting
- Salt – have a stockpile for winter but will order more this week

CLERK-TREASURER:

- The next scheduled meetins, which everyone is invited to attend:
 - 11/19/25 – Regular Board meeting at Village Hall at 7:00pm
- Unpaid 2025 village taxes are due by October 31, 2025; thereafter re-levied to Genesee County.

- Prep for next quarterly sewer billing. Bills mail out first week in November.
- The last 4 years of Board Agendas and Minutes have been taken down from the Village website. 2024 and 2025 files were converted using OCR (Optical Character Recognition) scanning which improves accessibility and makes them searchable.
- Board discussed installing a secure lock/drop box at Village Hall, coordinated with DPW.

MUNICIPAL HISTORIAN:

- Barn Quilt tours: Significant visitor interest (tour buses; many out-of-state inquiries).
- Board discussion:
 - Create a Barn Quilt map page on the Village website.
 - Install a plexiglass map display outside Village Hall (location to be coordinated).
 - Improve Village Hall exterior signage, coordinate with Police signage needs, get options/costs

RESOLUTION AUTHORIZING AN EXPENDITURE FROM POLICE EQUIPMENT RESERVE #1

MOTION BY: Trustee Tetrault

WHEREAS, pursuant to General Municipal Law section 6-c, the LeRoy Village Board of Trustees established a Police Equipment Reserve for the acquisition of equipment for the LeRoy Police Department; and

WHEREAS, the LeRoy Village Board has authorized the transfer of proceeds from the sale of surplus LeRoy Police Department equipment to the Police Equipment Reserve; and

WHEREAS, the LeRoy Police Department has determined the need to purchase police vehicles and negotiated with GSA Fleet Sales for \$9,000.00 to purchase a 2021 Dodge Durango, \$10,200 for a 2022 Ford Explorer, and \$4,700.00 to purchase a 2018 Dodge Charger; and

WHEREAS, the A895 Police Equipment Reserve has adequate funds to the cost of said purchase; and

NOW THEREFORE, BE IT RESOLVED, the LeRoy Village Board hereby authorizes the expenditure, retroactive to 10/8/25, from the A895 Police Equipment Reserve for the LeRoy Police Department to purchase the following from GSA Fleet Sales for a total of \$23,900.00:

RESOLUTION AUTHORIZING AN EXPENDITURE FROM POLICE EQUIPMENT RESERVE #2

WHEREAS, pursuant to General Municipal Law section 6-c, the LeRoy Village Board of Trustees established a Police Equipment Reserve for the acquisition of equipment for the LeRoy Police Department; and

WHEREAS, the LeRoy Village Board has authorized the transfer of proceeds from the sale of surplus LeRoy Police Department equipment to the Police Equipment Reserve; and

WHEREAS, the LeRoy Police Department has determined the need to upgrade dept. radios and to purchase weapons, ammunition, and miscellaneous equipment to accommodate new officers and meet community requirements; and

WHEREAS, the A895 Police Equipment Reserve has adequate funds to cover the cost of said purchase; and

NOW THEREFORE, BE IT RESOLVED, the LeRoy Village Board hereby authorizes the expenditure, retroactive to 9/12/25, from the A895 Police Equipment Reserve for the LeRoy Police Department to purchase the following for a total not to exceed \$24,500.00:

- \$8,662.50 Motorola radios – Flywire Global Corp via GovDeals
- \$5,093.60 weapons and ammunition – Amchar Wholesale Inc.
- \$5,859.80 weapon optics – Aimpoint Inc.
- Misc. equipment - Amazon

Resolution to Authorize Maintenance Expenditure

MOTION BY: Trustee Bonacquisti

WHEREAS property designated as Village of LeRoy Tax Map # 9.-2-24 is owned by McDonald's Corp. (#31101), and

WHEREAS the Village of LeRoy owns and maintains a public parking lot, designated Tax Map # 9.-2-23, which is accessed from Main Street and surrounds parcel #9.-2-24 on three sides, and

WHEREAS the Village has allowed McDonald's Corp. a right of way for customer driveway access to the restaurant, and

WHEREAS McDonald's Corp has determined the right of way and parking area require maintenance, and requests the Village split the cost of the estimated \$56,000 to mill, clean, asphalt, and stripe the right of way and parking lot, and

WHEREAS DPW Supervisor Bob Lathan has spoken with the McDonald's representative, viewed the site, and recommends the action, NOW THEREFORE

BE IT RESOLVED the Village of LeRoy Board of Trustees hereby approves the plan retroactive to 9/23/25, and authorizes an expenditure of \$28,000 to Nexgen Ventures, LLC, McDonald's of LeRoy, for the purpose of splitting the cost to mill, clean, asphalt, and stripe 16,236 sq. ft. of right of way and parking lot.

Sewer Exclusion Requests – 2 homeowners have requested sewer exclusion requests. **Trustee Bonacquisti made a motion for a Resolution to Approve a Sewer Exclusion of \$76.80 for 6 Garden Lane, Sewer Account #00750.** It was seconded by Trustee Kettle and passed with voting as follows: Trustee Tetrault – Aye, Trustee Kettle – Aye, Trustee Bonacquisti – Aye, and Mayor Rogers – Aye. **Trustee Bonacquisti made a motion for a Resolution to Approve a Sewer Exclusion of \$19.20 for 11 Wilson St., Sewer Account #07114.** It was seconded by Trustee Kettle and passed with voting as follows: Trustee Tetrault – Aye, Trustee Kettle – Aye, Trustee Bonacquisti – Aye, and Mayor Rogers – Abstain.

Festival Permit – **Trustee Tetrault made a motion for a Resolution to Approve a Festival Permit Application to LeRoy Business Council for the Main St. Halloween Parade on 10/31/25, 5:15 – 6:15pm.** It was seconded by Trustee Bonacquisti and passed with voting as follows: Trustee Tetrault – Aye, Trustee Kettle – Aye, Trustee Bonacquisti – Aye, and Mayor Rogers – Aye.

CITIZEN PARTICIPATION:

A resident showed his support for police presence in the schools.

OFFICIAL CONSIDERATIONS:

Trustee Bonacquisti: Told DPW Sup. Lathan that North St., South St., Church St. look excellent.

Trustee Kettle: the last Comprehensive Plan meeting was productive. They have further edits for clarity before public release.

Trustee Tetrault: He spoke with Town Supervisor Farnholz and asked him how much water they used at the pool/splash park this year. Supervisor Farnholz said about 1 million gallons.

Mayor Rogers: Thanks to everyone who served on the Comprehensive Plan committee and getting project lead Jenny Lowenstein was the best move they ever made. Plans will continue for the Wiss Lot for Christmas. He expressed his general appreciation for the increased police presence.

AUTHORIZATION TO PAY BILLS:

Trustee Bonacquisti made a motion to pay bills, reluctantly, retroactive to 9/19/25. It was seconded by Trustee Kettle and passed unanimously. Payment is as follows:

EXECUTIVE SESSION:

Trustee Bonacquisti made a motion to go into Executive Session for the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation. It was seconded by Trustee Tetrault and passed with voting as follows: Trustee Tetrault – Aye, Trustee Kettle – Aye, Trustee Bonacquisti – Aye, and Mayor Rogers – Aye. Mayor Rogers said he would like Chief Kellogg, Wastewater Supt. Carroll, and DPW Sup. Lathan, to stay. Session was entered at 7:30 PM.

RETURN TO REGULAR SESSION:

Trustee Kettle made a motion to Return to Regular Session. It was seconded by Trustee Bonacquisti and passed with voting as follows: Trustee Tetrault – Aye, Trustee Kettle – Aye, Trustee Bonacquisti – Aye, and Mayor Rogers – Aye. Session entered at 8:40pm. Mayor Rogers said no business was conducted during the session.

ADJOURN:

There being no further business before the Board, **Trustee Kettle made a motion to Adjourn**, seconded by Trustee Bonacquisti and passed unanimously. The meeting was adjourned at 8:41pm.
