The planning process included an evaluation of existing conditions (demographic, housing, income, environmental, land use, economic, recreation, transportation, etc.), involvement of the public to determine issues and future desired direction, and development of strategies and actions that can be implemented over the next decade to help the Village reach their community goals. The process included a residential survey, multiple planning workshops, a public hearing hosted by the Comprehensive Plan Steering Committee, regular meetings of an ad-hoc committee (Steering Committee) appointed to draft the plan for the Village, and other qualitative and quantitative studies assisted by a planning consultant. The plan includes extensive background information, vision and goals, strategies and actions, and a series of maps depicting various resources in the Village. Public hearings were held by both the Comprehensive Plan Committee and the Town Board. The Plan covers the entire portion of the Village. Adoption of such a plan is a Type I action under SEQR.

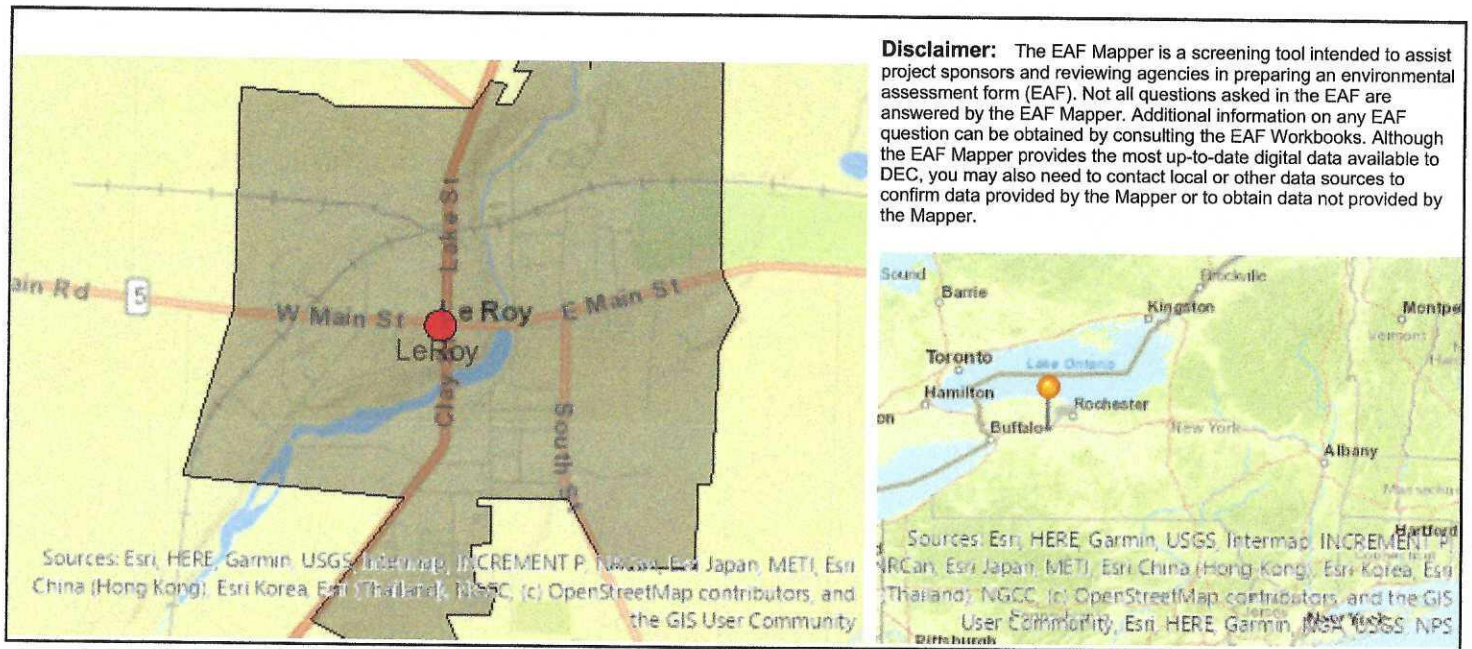
